I. INTRODUCTION

The college conducts 5 years' Bachelor Degree Course in Architecture (B. Arch.) as per the syllabus of the University of Calicut to which the college is affiliated.

II. NUMBER OF SEATS

Total Seats: 40 (20 Merit Seats and 20 Management Seats)

III. COUNCIL OF ARCHITECTURE NORMS FOR B. ARCH. COURSE FOR THE ACADEMIC SESSION 2024-2025 (AMENDED)

- a) Candidate must have attained 17 years of age as on 31st December, 2024.
- b) No candidate shall be admitted to architecture course unless she/he has passed an examination at the end of the 10+2 scheme of examination with at least 50% aggregate marks in Physics, Chemistry and Mathematics and also 50% marks in aggregate of the 10+2 level examination

Or

passed 10+3 Diploma Examination with Mathematics as compulsory subject with at least 50% marks in aggregate.

- c) In addition to the above, only those candidates who score the minimum eligibility marks as per the Information Brochure of National Aptitude Test in Architecture (NATA) 2024 or JEE (Paper-II) will be eligible for admission to B. Arch. Course.
- d) Candidates may note that no direct lateral admission is allowed at any year/semester/stage of B.Arch. course based on any qualification.

IV. HOW TO APPLY

a) Application Form

The application form together with the information brochure can be obtained from the college on payment of Rs.1000/- by cash or by sending Rs.1025/- by way of Demand Draft for getting the same by post.

b) Submission of Application Form

1. The application form can be submitted directly in the college or by registered post with A/D so as to reach the college on or before the prescribed date.
2. The candidate should fill in all the items in the application form in his/her own handwriting and should be complete in all respects.
3. Application not accompanied by documents in proof of claims made therein will be summarily rejected without further intimation.
4. Documents/certificates furnished after submission of the application form will not be entertained under any circumstances and no opportunity will be given to incorporate any details in the application form after its submission.
5. Late and incomplete applications will be summarily rejected.

6. List of copies of Certificates/Documents duly attested by a Gazetted Officer/Head of the Institution where the student last studied to be submitted along with the application form: 10th/12th Certificate in proof of date of birth. NATA Score Card. Certificate and Mark List of qualifying examination. Migration Certificate/Equivalency Certificate in case of students from other Universities/Boards.

V. ADMISSION PROCEDURE

Originals of all certificates/documents enclosed with the application should be submitted to the college at the time of admission. Physical Fitness Certificate (from Government Hospital in the prescribed format), Conduct & Character Certificate and Transfer Certificate (**all in original**) should be submitted to the college at the time of admission. The candidate should pay the fee in full at the time of admission.

VI. DISCONTINUATION OF THE COURSE AND PAYMENT OF LIQUIDATED DAMAGES

If any candidate discontinues the course after closing of admissions or the last date of admission mentioned in the agreement with the Government for admission to B. Arch. course by the ACMA, the candidate has to pay liquidated damages to the tune of full fee of the course. The student shall have the claim for TC and other certificates only after clearing all the dues.

VII. ACADEMIC RULES AND REGULATIONS

- The college will function from 9.30 a.m. to 4.30 p.m. for all semesters, with one hour break from 12.30 p.m. to 1.30 p.m. for lunch.
- Saturdays and Sundays are usually holidays for the college.
- An identity card with photograph will be issued to all students. Students must always wear the same when they are inside the college campus and must produce the same for inspection.
- Students are expected to attend all classes without fail.
- Every student is required to maintain a minimum of 75% attendance and 50% minimum separately for each subject for each semester, failing which the student cannot appear for the University examination.
- The student has to pay the fee every year of study on or before the 1st working day of the month of July from the second year to the fifth year and for the first year at the time of admission even if it is not notified to you individually in writing.
- Every student is bound by the rules and regulations of the institution currently existing and also those that may come into force in future. The management expects each student to contribute his/her best to the development of the Institution and to establish good relationship with fellow students.
- Requests for Bona-fide Certificates for Education Loans must be submitted in the Accounts Section in the month of May itself. Late submission of Applications for Education Loans will not be entertained.
- In addition to the Annual Fee, Examination Fee, Sports Affiliation Fee (SPA), University CAP ID Registration Fee and University Union Fee (UUF) has to be remitted to the University. The student has to remit the above along with Annual Fee every year. The defaulters will not be allowed to take part in University Sports and Cultural activities and also in College Election.
- From the Academic Year 2024-2025 onwards, hostel accommodation is compulsory.
